## ORDER:

In the GO's 1st, and 2nd read above. Government have appointed Sri D.Sankaraguruswamy, I.A.S., (Retd.) as Pay Revision Commissioner. Various Service Associations have been requesting for sanction of Interim Relief pending recommendation of the Pay Revision Commissioner and decision of Government thereon.

After careful examination Government hereby sanction Interim Relief at the rate of Rs.60/- per month to those employees drawing pay in the scale of Rs.860-1470 and less and Rs.100/- per month to those employees drawing pay in the scale of Rs.910-1625 and above, subject to the following conditions:

- 1. The Interim Relief shall be payable till the revision of pay scales and shall be adjustable against any benefit that may accrue to the employees on account of revision of scales of pay and other allowances as a result of Government's decision on the Report of the Pay Revision Commissioner.
- 2. The Interim Relief shall be applicable to all Government employees, employees of Local bodies, teaching and nonteaching staff of Zilla Praja Parishads, Mandal Praja Parishads, Municipalities, Municipal Corporations and all other employees of Gram panchayats, Mandal praja Parishads, Zilla Praja Parishads, Municipal Corporations and Zilla Grandhalaya Samsthas, Agricultural Market Committees, teaching and nonteaching employees of aided Schools, Junior Colleges and Degree Colleges and nonteaching staff of all Universities including APAU and JNTU drawing pay in the A.P. Revised Pay Scales of 1986 and work charged establishment who get monthly pay in a regular pay scale of Revised Pay Scales 1986, excluding the teachers and other employees who are drawing pay in the Revised UGC pay scales, 1986.
- 3. The Interim Relief will however, not be applicable to Junior Lecturers in Junior Colleges (Government and aided) for whom orders have been issued in the G.O.4th read above.
- 4. The Interim Relief will not be admissible to the Contingent Establishment including Part Time Contingent Establishment.

- 5. The Interim Relief shall be payable from the month of June, 1992 payable on 1st July, 1992.
- 6. The Interim Relief shall not be taken into account for purposes of computation of DA or any other allowance.
- 7. All the Departments of Secretariat and Heads, of Departments are requested to take prompt steps to provide additional funds under the relevant Heads of Account.
