ORDER:-

In Government order 2nd read above, orders were issued sanctioning House Rent Allowance at the rate of 15% of pay subject to a maximum of Rs.400 p.m to the employees whose places of Duty in Hyderabad and Secunderabad, Visakhapatnam, Warangal, Vijaywada and Guntor and 7 ½ % of pay in Respect of other Places where population exceeds 50,000 but does not exceed 2 Lakhs new places were subsequently included in the list of places where the HRA is Admissible either at 15% or at 71/2% of pay vide G.Os. 4th to 7th and 9th read above. Subsequently House Rent Allowance at 4% of pay was sanctioned to the employees working in Head quarters of Taluks and sub Taluks or Municipalities and Municipal Towns and Head quarters of panchayat samithis which are not Taluk and sub Taluk Head gurters and where no House Rent Allowance or compensatory allowance in lieu of House Rent allowance was admissible vide G.O.Ms.No 43, Finance and Planning (F W.PRC.I) Department, Dated 4-2-1980 G.O.Ms.No.6, Finance and Planning (F W.PRC.I) Department, Dated 6-1-1981, G.O.Ms.No.6, Finance and Planning (F W.PRC.I) Department, Dated 17-12-1982 and G.O.Ms.No. 5, Finance and Planning (F W.PRC.I) Department, Dated 7-7-1983. Thus the HRA is admissible at 15%, 71/2% or 4%

according to the place of duty. The pay Revision commission, 1986 appointed with the terms and conditions as laid down in the order first read above has recommended payment of HRA AS FOLLOWS:-

- I. HRA at 20% of pay in places where 15% is now admissible subject to a minimum of Rs 150/ pm
- II. HRA of 10% of pay in places where 7½% or 4% is now admissible, subject to a minimum of Rs 75% pm
- III. In either case the Maximum HRA shall be Rs 1000/- as against the existing maximum of Rs 400 pm

Government have accepted the recommendations of the PRC and here by order as follows:-

- a) HRA at 20% of pay instead of 15% shall be admissible in cases where the places of duty is in Twin cities, Vishakapatnam, Vijayawada, Warangal, Guntur. Rajamandry, Nellore, Kakinada, Kurnool, Tirupathi and Nizamabad, The rate of HRA shall be subject to a minimum of Rs 150/- pm
- b) In the other places where the present Rate of HRA is $7\frac{1}{2}$ % or 4% the revised rate of HRA shall be 10% the rate of HRA shall be subject to a minimum of 75 pm
- c) The HRA shall be subject to a maximum of Rs 1000/pm
- d) Pay for the purpose of calculation of HRA under as order shall be the pay in the Revised pay scale, 1986.
- e) The existing orders and clarifications in regard to the admissibility of HRA to those employee whose place of duty is within 8 KM. belt shall continue to apply
- f) The existing definition of pay for the purpose of calculation of HRA shall continue to apply
- g) HRA will not be admissible to those employees who are provided with Rent free accommodation
- h) In Respect of the employee who are Provided with Government quarters, the Recovery or rent shall be made at the same rate, as was done before the pay is fixed in the Revised pay Scales, 1986 until further Orders.
- i) These orders shall also apply Mutatis, Mutandis to all Categories of personnel Viz., Government employees, teaching and Non-teaching staff of Government employees, teaching and Non-teaching staff of Government Colleges, Government Junior Colleges, Zilla Parishads, Panchayat Samathis and Municipalties, all other employees of Gram Panchayat Samathis, Zilla Parishads, Municipalities, Zilla Grandhalaya Samathis Agricultural Market committees and work- charged establishment who get Monthly pay in the revised PAY SCALES, 1986.

- J) In respect of the employees drawing pay in Andhra Pradesh Revised pay scales, 1976 the pay means the pay plus D.A. at 320 points which was treated as pay for the purpose of claiming HRA
- (5) These orders shall take effect from 1st July, 1986.
- (6) These orders shall not apply to the police personnel at the Rank of Inspectors and below for whom separate orders shall be issued by home Department.
