ORDER:

In the Government Order first read above, orders were issued revising the pay scales of the State Government employees based on the recommendations of the Pay Revision Commissioner, 1993 with effect from 1st January, 1993 with monetary benefit from 1st April, 1993. In the said orders, the State Govt. employees were allowed to exercise option to draw the Revised Pay Scales, 1993 either from 1-1-1993 or from the date on which the employee earns his next increment in the existing scale of pay, but not beyond 31-12-1993. Subsequently, in pursuance of an agreement reached with the joint Action committee of Employees, Teachers, Workers of .Andhra Pradesh and A.P. Secretariat Co-ordination Committee on 17-12-1993, orders were issued in Government order 3rd read above implementing the recommendations of Pay Revision Commissioner, 1993 from 1-7-1992 with monetary benefit from 1-4-1993. Consequently the State Government employees were allowed to exercise option to draw pay in the Revised Pay Scales, 1993 either from 1st July, 1992 or from the date on which he earns his next increment in the existing scale of pay but not beyond 30-6- 1993. Consequent on implementation of Government order 3rd read above, some of the employees are placed at a disadvantageous position as there was drop in their emoluments. The Joint Action Committee of Employees, Teachers, Workers of Andhra Pradesh has represented to the High Power Committee headed by Sri A.V.S. Reddy, which was constituted in the Government Order 4th read above that during !078 Pay Revision, the employees were permitted to exercise options to come into the Revised Pay Scales with effect from the date of implementation or date of next increment or date of subsequent increment but not later than 31-3-1980 and they have therefore requested that similar opportunity may be extended for this Pay Revision also to avoid loss in emoluments to some of the employees. The Committee after due consideration amongst others has recommended that the employees may be permitted to exercise similar option as allowed for 1978 Pay Revision.

2. The Government have decided to accept the recommendations of the High Power Committee. Accordingly, Government hereby order that the employees shall be allowed to exercise option ID elect lo come to the Revised Pay Scales 1943 not only from 1-7-92 or the

dale of next increment in the existing scale of pay accruing after 1-7-92 hut also 1-7-93 bill not beyond 30-6-94.

- 3. Government also hereby order that employees affected by the above order are permitted to exercise their option before 31-12-1994.
- 4. The following Notification will be published in the Andhra Pradesh Gazette:

NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Revised Scales of Pay Rules, 1993 as subsequently amended.

2. The amendments hereby made shall be deemed to have come into force with effect on and from the 1st July, 1992.

AMENDMENTS

In rule 5 of the said rules:

- (a) for sub-rule (1), the following shall he substituted, namely:
- "(I) Subject to other provisions of this rule, a Government employee holding a post under the Government on 1st July, 1992, the scale of which is revised may opt.
 - (a) to remain in the existing scale of pay; or
- (b) to draw pay in the revised pay scales, 1993 either from 1st July, 1992 or from the date on which he earns his next increment in the existing scale of pay or from the date of subsequent increment in the existing scale of pay but not beyond 30-6-1994."
- (c) in clause (b) of sub-rule 3, for the date '30-6-1993', the date '30-6-94' shall be substituted.
